

## **MOSSEL BAY MUNICIPALITY**

### **PROPOSED LEASE ERF 668, SITUATED ADJACENT TO LE ROUX ROAD, REEBOK (±688M<sup>2</sup>)**

Notice is hereby given in terms of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) read with the Asset Transfer Regulations, R878 of 2008, the Promotion of Administrative Justice Act, 2000 (Act 3 of 2000) as well as the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) that the Council of the Mossel Bay Municipality intends to lease Erf 668, situated adjacent to Le Roux Road, Reebok (±688m<sup>2</sup>) to E. and L Marais for a period of three (3) years, at a rental amount of R416,00 per annum (VAT inclusive), with an annual escalation equal to the CPIX- percentage. The applicable CPIX-percentage shall be the CPIX of two (2) months prior to the date of escalation in terms of the agreement. The said property is not needed for basic municipal services, the asset remains the property of Council and the property to be utilised as a garden and parking purposes. No rights will be vested prior to the Lease Agreement being signed by both parties.

### **VOORGESTELDE VERHURING VAN ERF 668, GELEË GRESEND AAN LE ROUX WEG, REEBOK (±688M<sup>2</sup>)**

Kennis geskied hiermee in terme van die Wet op Plaaslike Regering: Munisipale Finansiële Bestuur 2003 (Wet 56 van 2003) saamgelees met die Bate-oordragregulasies, R878 van 2008, die Wet op Bevordering van Administratiewe Geregtigheid, 2000 (Wet 3 van 2000) en die Wet op Plaaslike Regering: Munisipale Stelsels, 2000 (Wet 32 van 2000) dat die Raad van Mosselbaai Munisipaliteit beoog om Erf 668, geleë grensend aan Le Roux Weg, Reebok (±688m<sup>2</sup>), aan E en L Marais te verhuur, vir 'n tydperk van drie (3) jaar, teen 'n bedrag van R416.00 per jaar (BTW ingesluit), met 'n jaarlikse eskalasië-aanpassing gelykstaande aan die VPI-persentasie.
