INVITATION TO PARTICIPATE IN THE CONTRACTOR DEVELOPMENT PROGRAMME, 2021

INVITATION TO APPLICANTS

The Mossel Bay Municipality hereby invite contractors from the construction industry (within the General Building; Civil Engineering, Electrical Engineering Works Building sector) to participate in a Contractor Development Programme (CDP) of Mossel Bay Municipality. This Programme is an initiative of the Municipality that seeks to promote sustainable development of small to medium-sized contractors and intends to contribute towards the provision of economic opportunities within the sector. The programme is targeting CIDB registered contractors grading 1 – 2GB, 1 – 2CE, 1 – 2EB Construction companies owned and controlled by locals. Historically Disadvantaged Individuals from the following categories are motivated to register:

- a) Women;
- b) Youth;
- c) People with Disabilities; and
- d) Military Veterans.

Application forms can be obtained from the Economic Development Department, Montagu Street, Montagu Place Building, 4th floor, the LED Offices at the Good Shed in Bland Street and Municipal Website.

SELECTION CRITERIA:

- 1) Requirements for Applicants:
 - a. The contractor must have a valid registration on National Central Supplier Database (CSD) as per requirements for bidding for public tenders.
 - b. The applying contractor must have a valid Construction Industry Development Boards (CIDB) registration.
 - c. The contractor must be a South African citizen.
- 2) Compulsory documents to be submitted:
 - a. Application form (available at the Economic Development Department, Montagu Street, Montagu Place Building, 4th floor, the LED Offices at the Good Shed in Bland Street and Municipal Website at www.mosselbay.gov.za).
 - b. Central Supplier Database Report;
 - c. Provide a Tax Compliance Status PIN;
 - d. Proof of Valid CIDB registration;
 - e. Proof of business address; e.g. Municipal Bill, Rental Agreement;
 - f. Certified copy of ID (not older than three months).

Contractors that do not submit compulsory documents or qualify on the conditions will not be considered. Where, your municipal account or business address is not within the boundaries of Mossel Bay Municipality you will also not be considered for this programme.

The Mossel Bay Municipality Local Economic Department (LED) will review all applications received by the closing date and compile a shortlist of the qualifying contractors. The expectation should not be that every registered contractor will move to a higher Grade but may get an opportunity to excel.
